Resolution

An Application has been duly made to the Board of the Town of Afton, County of Chenango, New York, by Time Warner Cable Northeast LLC ("Time Warner Cable"), d/b/a/ Time Warner Cable, a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 120 Plaza Drive, Suite D, Vestal, New York 13850 for the approval of an initial agreement for Time Warner Cable's cable television franchise for five (5) years commencing with the date of approval by the Public Service Commission. The Franchise Renewal Agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings.

A public hearing was held in the Town of Afton, New York on December 10, 2015 at 7 PM and notice of hearing was published in the Tri Town News on November 25, 2015.

NOW, THEREFORE, the Board of the Town of Afton finds that:

1. Time Warner Cable has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and

- **2.** Time Warner has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- **3.** Time Warner Cable can reasonably meet the future cable- related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED THAT THE Board of the Town of Afton hereby grants the cable television franchise of Time Warner Town of Afton for five (5) years commencing with the date of approval by the Public Service Commission and expiring five (5) years hence.

BE IT FURTHER RESOLVED THAT THE Board of the Town of Afton hereby confirms acceptance of this Franchise Agreement.

The foregoing having received a yes vote was thereby declared adopted.
